Board Action Requested

It is requested that the Executive Committee of the Michigan Works! Southeast Workforce Development Board approve a contract with Annodyne in the amount of \$74,490 for marketing and outreach services for the time period April 5, 2017 through December 31, 2017.

Background

Staff released a Request for Proposal (RFP) to solicit proposals for an organization to provide marketing and outreach services the agency. Proposals were due on March 3, 2017. Due to timing issues, the Workforce Development Board (WDB), in Resolution 16-59, gave the Executive Committee of the WDB approval to review the recommendations of a review committee and select a provider for program implementation in early/mid April.

Discussion

The review committee met and reviewed all fourteen of the proposals. After discussion and grading, Annoydyne was selected to be the provider of the marketing and outreach services. The committee approved a contract in the amount of \$74,490 for the time period April 5, 2017 through December 31, 2017.

Approval of the Agreement is contingent upon approval by the Executive Committee of the Michigan Works! Southeast Workforce Development Board. A Resolution is attached for your consideration.

- WHEREAS, A Request for Proposal was released to solicit proposals from agencies to provide marketing and outreach services to the agency; and
- WHEREAS, Fourteen proposals were received and reviewed by a review committee; and
- WHEREAS, The review committee recommends Annodyne to receive the contract in the amount of \$74,490; and
- WHEREAS, The Michigan Works! Southeast Workforce Development Board granted final contract approval authority to the Executive Committee of the Workforce Development Board in Resolution 16-59, passed at the March 8, 2017 meeting; and
- WHEREAS, The contract requires approval from the Executive Committee of the Michigan Works! Southeast Workforce Development Board.
- IT IS THEREFORE RESOLVED the Executive Committee of the Michigan Works! Southeast Workforce Development Board hereby approves the contract with Annodyne in the amount of \$74,490 for the time period April 5, 2017 through December 31, 2017.

Board Action Requested

It is requested that the Michigan Works! Southeast Workforce Development Board approve a FY 2016 Workforce Innovation and Opportunity Act (WIOA) Incumbent Worker contract for KRT Precision Tool and Manufacturing in the amount of \$6,600.

Background

FY 2016 WIOA Incumbent Worker (7/1/16 through 6/30/17) training contracts are an important part of the Business Services run in the five counties of the Southeast Michigan Consortium. KRT Precision Tool and Manufacturing is requesting training in sales/marketing training and website training in the amount of \$6,600 to train 3 employees from April 5, 2017 through September 30, 2017.

Discussion

WIOA expands the funding available for Incumbent Worker funds (up to 20% of WIOA Adult and up to 20% of WIOA Dislocated Worker funds). Incumbent Worker funds are used to train currently employed workers to help avoid layoffs, learn new, necessary skills and/or help keep the company competitive. As part of this process, TIA has asked local Workforce Development Boards (WDBs) to review and comment on the proposals in their area. The main focus was to see how aligned the plan and program of the Adult Education applicant was with the regional and local Workforce Innovation and Opportunity Act (WIOA).

Ten Title II applications were deemed by TIA to be eligible for consideration and all were reviewed. All of the proposals were graded "highly aligned" or "moderately aligned" (none were "little/no alignment"). The following organizations applied for Title II funding:

Additionally, all organizations that are awarded funding through TIA will require a MOU to be executed with the WDB. Since it is not known at this time who will receive funds, staff are asking for WDB approval to negotiate and execute MOUs with all agencies that are awarded when determined by TIA. Infrastructure Funding Agreements, like with WIOA required partner MOUs, may be necessary.

Approval of the confirmation of Title Adult Education application reviews and negotiation and execution of MOUs is contingent upon approval by the Michigan Works! Southeast Workforce Development Board. A Resolution is attached for your consideration.

MICHIGAN WORKS! SOUTHEAST WORKFORCE DEVELOPMENT BOARD COMMITTEE DESCRIPTIONS

Employer Services Committee

This committee oversees the development and delivery of business services and sector initiatives. The committee establishes local policies for demand driven training services such as incumbent worker training, customized training, apprenticeships, on-the-job training and the Skilled Trades Training Fund. Committee members review requests for incumbent worker funding, and make recommendations to the board.

Using appropriate labor market information and economic data, the committee identifies approved occupational areas for training. It also identifies appropriate industry targets for sector initiatives and develops strategies to convene partners to address identified issues impacting the selected sectors. The committee is responsible for maintaining strong linkages with local economic development partners, and establishes outreach and marketing priorities directed toward business services.

Meeting Frequency: Monthly

<u>Data and Reports:</u> The committee will review labor market supply and demand data, occupational and industry forecasts, data on skill gaps, and training program performance and outcomes. The committee will also review regular reports on business services including the numbers and types of business customers, services provided, and the impact of marketing and outreach efforts.

Talent District Career Council

The Talent District Career Council aims to better connect business and education in order to develop and retain talent in our region. Members are appointed by the Workforce Development Board and membership must conform to state policy. As an advisory group to the WDB, the TDCC will coordinate with high schools, community colleges, career and technical education programs, adult education programs and other educational entities in support of the WDB's mission and strategic workforce development plans. It will support work-based training opportunities such as internships, work experience, job shadowing, MI Bright Future, and similar activities which promote lifelong learning and career development. In accordance with state policy, it will also make recommendations on Adult Education and Career and Technical Education programs.

Meeting Frequency: At least quarterly and as needed.

<u>Data and Reports:</u> The committee will review regular reports on adult education, career and technical education, and career preparation activities, including the numbers and types individual served and program performance and outcomes.

Job Seeker Services Committee

This Committee will oversee programs and services for job seekers enrolled in workforce programs administered by Michigan Works! Southeast including resource room services, career services, job search assistance, workshops, training and support services. The primary focus of the committee will be to design a system which enables job seekers to attain self-sufficiency by moving unemployed workers into the labor force as quickly as possible. Special emphasis will be on services to priority groups such as welfare recipient, individuals with disabilities, veterans, offenders, high school dropouts, and at risk older youth. The committee will encourage, develop and oversee partnerships and collaboration with those organizations and resources which are working in our community to address the root causes of unemployment.

Meeting Frequency: Monthly

Data and Reports: Program outcome and performance reports, community needs assessments, data on high priority groups.

Compliance, Finance, and Oversight

The Compliance, Finance, and Oversight Committee will have the primary responsibility for ensuring that board resources are used efficiently and effectively to achieve the board's goals, and to comply with funding source rules. It will provide fiscal oversight responsibility for all Council activities and will review and recommend the overall operating budgets for MWSE. The committee will monitor expenditures, insure that appropriate fiscal controls are in place, and review financial reports, audits and monitoring reports.

Meeting Frequency: At least quarterly or as needed.

<u>Data and Reports:</u> Expenditure reports and projections, audits, monitoring reports, revenue forecasts.
